## **HEALTH AND SAFETY**

#### **Emergencies:**

Call the police at 911. As a reminder, the police will NEVER ask about your immigration status.

#### **Cook County Health:**

For healthcare call 773-395-9050 (assistance is available in Spanish).

#### **Department of Children and Family Services:**

- For help with guardianship, call 312-814-8600 (assistance is available in Spanish).
- To report child abuse or neglect, call 800-25-ABUSE (800-252-2873), dial 2 for assistance in Spanish.

#### Pregnant Women, Infants, and Children (WIC):

For additional food for pregnant women and small children, call 217-782-2166 (assistance is available in Spanish).

#### Victims of Trafficking Torture or other Serious Crimes (VTTC) Benefit:

A public benefit that includes the medical card (health insurance) and a food/cash assistance card. Contact an Illinois Welcoming Center for more information.

# **LEGAL ASSISTANCE**

#### **Legal Services:**

312-660-1328 for a possible consultation by immigration professionals (assistance is available in Spanish).

#### **Know Your Rights:**

The U.S. Constitution provides you with basic rights. The Illinois TRUST Act (5 ILCS 805) restricts local law enforcement from collaborating with federal immigration enforcement agents to detain anyone without a judicial warrant. In an encounter with an immigration or law enforcement officer, inform them of your rights:

- To remain silent and not answer questions.
- To contact an attorney immediately, if you are detained.
- To refuse to sign anything without advice from an attorney.
